- **1. APOLOGIES FOR ABSENCE.** Mr Eason, (Illness) Apologies accepted by Council., Cllr J Eliot SNC, Cllr J KirkbrideNCC.
- **2. DECLARATIONS OF INTEREST.** EC, and JC declared a personal interest regarding the Old School Hall; JC and MB as Trustees of the Charity and Youth Club. DB JC SR regarding the Harpole Action Team. DS regarding the allotments and SHLAA.OSH and PFA. MB regarding the PFA. DS regarding the payments.
- 3. PUBLIC DISCUSSION. None.
- **4. APPROVAL OF MINUTES** of the meeting of 9th May 2011. It was then proposed, and seconded that the minutes were accepted as a true record. Unanimous. The Chairman duly signed the agenda and minutes.

5. MATTERS ARISING FROM THE MINUTES;

Representatives for Mid Northants Parishes will be DB, JC and MB.

Shed outside 1 Glassthorpe Lane. – Clerk reported that last date for appeal had now passed and Shed would be removed by the end of the month.

Regarding people and dogs using the Playing Field as a footpath. The Playing Field Committee felt that was not a problem, that there was no evidence of dog fouling, and it would be impossible to police the area in any case

<u>State of the roads around Larkhall Way.</u> NRHA had replied that the developers SDC would do remedial works when site clear. Clerk had contacted NCC who would now request SDC did this. Clerk to ask NHRA for photographs so that comparisons can be made with roads before the development.

<u>New Village Hall</u> Mr Shuttleworth of SNC has informed Council that if any Section 106 money is to be had; costings, a justification, and a business plan were required – but that there was only a small chance in any case as the money had largely been allocated already – despite the fact that the development has not yet been authorised. OSHMC and HAT to discuss. EC to approach a contact at Kislingbury. Clerk to request information regarding the development.

- **6. Standing Orders.** In line with the internal auditors recommendations it was recommended that the following changes be made. To section 29b of Standing Orders should be added the wording "except in the case of regular payments such as lighting, electricity. grasscutting and insurance."
- *Resolved. Proposed Changes to be made to Standing Orders.
- **7. Financial Regulations.** To the Financial regulations a new clause 3.8 should be added with the wording.
- "Any proposed contract for the supply of goods, materials, services or works with an estimated value in excess of £1000 shall be procured on the basis of a formal tender as summarised in standing order 29(c), except in the case of regular payments such as lighting, electricity, grasscutting and insurance"

8. REPORTS FROM ADVISORY COMMITTEES.

Allotments. – RG reported that plots needed remarking. It was felt that hedgecutting was inconsistent, she would approach contractor when hedge is to be cut. JE wished to give up the allotments, RG volunteered to take over the responsibility.

Clerk to write to the householder regarding the Yew hedge on the West side, and to ask if there were any exceptions to contractors having public liability insurance. EC wondered whether Church walls etc were insured. Clerk to enquire. BG asked to see a copy of the agreement between the PCC and Council.

Finance. – Meeting held on May 20th to discuss Insurance policy. Internal Auditor had expressed concerns about the linkage of Councils policy with that of the OSH. DB felt that the concerns were unfounded. Clerk had ascertained that the insurance was subject to a 3 year agreement, and that a separation could not take place this year, further quotes were therefor not able to be actioned.

Clerk to thank NCC for clearing the footpath between Kislingbury turn and the bridge and ask them to clear the cycle path between the Turnpike and Kislingbury turn.
